Photographs to be stripped into circles or ovals should have plenty of background showing. Any holes, tears, creases, ink or pencil marks, clear tape, etc. over photographs, logos or copy to be reproduced will show up on final copy. Dark colors such as red, orange, etc. will reproduce as solid black.

Old, light green, blue, yellow **DO NOT** reproduce well. Negatives will be charged at a double the contracted rate of halftones.
